PREFACE

The main objective of publishing Annual Public Debt Bulletins is to provide stakeholders with timely and comprehensive public debt information and data regarding both external and domestic debt position of the country, detailing the stock of public debt and its main features. The provision and publication of public debt information on a regular basis is part of our public debt management reforms aimed at ensuring debt accountability and transparency.

The Bulletin provides information on public debt as at end December 2021 as follows:

- Total public debt;
- Domestic debt;
- External debt;
- Domestic financing;
- Special Drawing Rights;
- · Costs and risks of existing stock of debt; and
- Contingent liabilities.

Public debt information is also published in the Statement of Public Debt, which accompany the National Budget Statement; the Mid-year National Budget Review, the Annual Borrowing Plan, and in the Estimates of Expenditure (Blue Book). In addition, the ZPDMO reports on public debt to Parliament through the Report on Public Debt.

To broaden the scope and coverage of public debt, the ZPDMO is working on collecting and compiling the data on contingent liabilities from all public sector entities. This will improve public debt reporting, and will enhance monitoring and management of debt, including risk management.

In addition, the Bulletin also includes Annexes of various debt tables, to allow stakeholders to customize and undertake detailed analysis of public debt.

MACROECONOMIC DEVELOPMENTS AND TOTAL PUBLIC DEBT

Macroeconomic Developments

- 1. The Covid-19 pandemic hit the country at the beginning of 2020, to which Government swiftly responded by introducing restrictions and lockdowns in March 2020 to curb the spread of the virus. These measures managed to contain the Covid- 19 pandemic. However, the economy was negatively impacted resulting in low productivity, reduction of demand for goods and services, high recurrent expenditures to fight the pandemic and low revenue outturn.
- 2. Despite the devastating impacts of Covid-19, the economy is estimated to have grown by 7.8 per cent in 2021, on account of growth in agriculture, electricity, mining and construction. In addition, inflation also declined from a peak of 837.5 per cent in July 2020 to 60.7 per cent in December 2021, due to adherence to prudent fiscal and monetary policy measures, including reserve money targeting.
- 3. On another positive note, the fiscal deficits remained within the 3 per cent of GDP in line with the NDS1 and the SADC Macroeconomic Convergence Criterion with the country registering a budget surplus of 1.7 per cent of GDP in 2020 and deficit of 0.46 per cent of GDP in 2021.

Stock of Total Public Debt

- 4. The stock of total Public and Publicly Guaranteed (PPG) debt (domestic and external) amounted to ZWL\$ 1.86 trillion as at end December 2021, including RBZ external debt and compensation of Former Farm Owners. Of this total PPG debt, ZWL\$1.45 trillion is external debt, while ZWL\$412.9 billion is domestic debt.
- 5. The total PPG debt represents 62.1 per cent of GDP, which is within the limit of 70 per cent as provided for in the Public Debt Management Act.

6. Figure 1 shows the composition of total public debt, where external debt constitutes 78 per cent and the balance of 22 per cent is domestic debt.

DOMESTIC DEBT

Stock of Domestic Debt

- 7. The stock of domestic debt as at end December 2021 increased to ZWL\$ 412.9 billion, from ZWL\$16.7 billion as at end December 2020 14 per cent share of GDP, in 2021, compared with 1.4 per cent in 2020. This increase is due to inclusion of compensation to Former Farm Owners in domestic debt data.
- 8. Compensation of Former Farm Owners is included in domestic debt as these farmers were Zimbabwe residents at the time of acquisition of farms. Debt is classified by residence of the holder or creditor, where debt from foreign resident creditors is classified as external, while debt from domestic resident creditors is classified as domestic.
- 9. The domestic debt figures do not include claims on central Government by the RBZ amounting to ZWL\$15 billion, as at end December 2021. This is pending reconciliation between central Government and the RBZ, which will inform expenditure items under the relevant Line Ministries.



Maturity Profile of Outstanding Domestic Debt

10. Figure 2 shows the maturity profile of outstanding treasury bills and bonds as at end December 2021. The profile is downward sloping indicating the short-term nature of domestic securities, with more than 65 per cent maturing in 2022, implying a high refinancing risk.

EXTERNAL DEBT

Stock of External Debt

- 11. Total Public and Publicly Guaranteed (PPG) external debt stock as at end December 2021 stood at US\$13.35 billion, of which 42 per cent is owed to bilateral creditors, 20 per cent to multilateral creditors and 37 per cent is RBZ external debt (including blocked funds).
- 12. Arrears on external debt which amounted to US\$6.6 billion (49 per cent of total PPG external debt), remain a major protracted challenge to restoring debt sustainability and to the economy, resulting in the lack of access to official external financing.

Externa Debt Service

- 13. During the period January to December 2021, Treasury made total external debt service payments amounting to US\$59.30 million, comprising of US\$49.7 million for the active portfolio and US\$9.60 million as token payments to the Multilateral Development Banks (MDBs) and Paris Club creditors. Government in September 2021, started making US\$100 000 quarterly token payments to each of the 16 Paris Club creditors.
- 14. As at end May 2022, since the resumption of the token payments, a total of US\$8 million token payments were made to the MDBs and US\$ 4.8 million to the Paris Club creditors.

External Loan Disbursements

15. Disbursements of external on-lent loans, for the period January to December 2021, which were from the China Eximbank for the Zimbabwe Power Company (ZPC) Hwange 7 & 8 Thermal Power Station project and the India Exim Bank for the ZPC Deka Pumping Station and River Water Intake System project, amounted to US\$24 million and US\$3.9 million respectively. The OPEC Fund for International Development (OFID) also disbursed a total of US\$8 million for the three projects namely, Poverty Alleviation, First Education and Smallholder Irrigation Revitalisation.

16. The low disbursements loans are due to accumulation of arrears to active China Eximbank loans (amounting to US\$266 million) on projects such as Victoria Falls Airport (US\$54 million), NetOne Network Expansion Phase I & II (US\$ 61 million) and Expansion of the R.G. Mugabe International Airport (US\$3 million).

External Loans Concluded in 2021

17. Government, in 2021, signed a concessional loan (grant element of 47.65 per cent) with the IFAD amounting to US\$35.7 million for smallholder irrigation schemes targeting market oriented and climate smart value chains. The project will benefit 78 000 households in the provinces of Matabeleland North, Midlands, Mashonaland West, East and Central. This project is going to be co-financed with a US\$15 million OFID loan to be concluded in second quarter of 2022. In line with the legal requirements, this loan was gazetted on the 13th of August 2021 and was subsequently approved by Parliament on the 11th of November 2021.

Reserve Bank of Zimbabwe External Debt Stock

18. The RBZ's total external debt stock as at end December 2021, amounted to US\$1.421 billion, representing 5 per cent of GDP. Reporting of RBZ debt is in line with prudent public debt management practices aimed at enhancing transparency and accountability. Of the total RBZ external debt, Afreximbank is owed a total of US\$ 1.240 billion (87 per cent) (see Table 8).

Blocked Funds

19. The Blocked Funds/Legacy Debts emanated from currency reforms by Government, where the RBZ accumulated foreign currency payments for goods and services, which it could not remit due to shortages of foreign exchange. These blocked funds amounted to US\$ 3.35 billion as at end December 2021.

- 20. Government in December 2021, assumed these debts through the Finance Act No. 7 of 2021. The following are the criteria, terms and conditions for the assumption of the banking sector's blocked funds/ legacy debts:
 - Any liability payable in foreign currency that was incurred before the 22nd February 2019,
 and in respect of which such foreign currency could not be repatriated from Zimbabwe;
 - The claim must have been submitted on or before 20 April 2020 for validation by the RBZ;
 - The equivalent, in Zimbabwe dollar, of the blocked funds must have been remitted to the RBZ; and
 - Validation and reconciliation of individual Claimant's debt by the Zimbabwe Public Debt Management Office.

- 21. Treasury is going to settle blocked funds through both cash payments and issuance of zero-coupon Treasury bonds ranging from 3 to 20 years in a gradual phased approach, which is non-inflationary, taking into account the availability of resources, fiscal sustainability, maturity profile and debt sustainability. For claims of more than US\$1 million, zero-coupon Treasury bonds will be issued with the following maturities: 3|5|8|10|12|15|18|20 years. For claims below US\$1 million, cash payments will be made over a period of 5 years.
- 22. The detailed list of assumed blocked funds as published in the Finance Act No.7 of 2021, is attached in Annex 7, 8 and 9.

DOMESTIC FINANCING

Treasury Bills Issuances


- 23. Domestic financial and capital markets are the major source of budget financing, as access to external sources remains constrained due to the accumulation of external debt arrears. In 2021, Treasury raised ZWL\$39.17 billion for budget financing through the auction (24.33 per cent) and private placements (75.67 per cent).
- 24. The cost of borrowing for the period under review, was average interest rates of 21 per cent for 365-day TB, 19 per cent for 270-day TB, 17 per cent for 180-day TB and 15 per cent for 90-day TB. Almost all of these resources were from the banking sector (99 per cent), while the non-banking sector provided the remainder (1 per cent).
- 25. The non-banking sector comprising of pension funds and insurance companies are not complying with the Prescribed Asset Status of 20 per cent against their current holding which was at 4 per cent as at end December 2021.

26. Primary holders of the Treasury bills at the issuance point are shown on Figure 3, where the top four holders (76 per cent) of Government securities are Nedbank, Ecobank, Steward and Stanbic Bank.



Domestic Loans Concluded in 2021

27. In addition to Treasury bills issuance for budget financing, Government concluded a domestic loan with Fossil Mines amounting to US\$88 million for the construction of the Harare- Masvingo Road Interchange (Mbudzi) with the terms indicated in Table 11. The loan includes a US\$26 million down payment by Government to unlock the facility.

SPECIAL DRAWING RIGHTS

- 28. Government, in August 2021 received Special Drawing Rights (SDRs) allocation amounting to US\$960 million from the International Monetary Fund (IMF). The allocation is a huge stimulus to the economy, following the devastating impact of COVID-19 pandemic. As approved by Cabinet and Parliament, these SDRs will be utilised over a period of three years (see Annex 1).
- 29. In 2021, as part of budget financing, Government made two drawdowns amounting to US\$279.7 million and utilised these resources towards health (Covid-19 vaccination programme), agriculture (construction of dams), social protection (education safety nets) and infrastructure development (road construction) as indicated on Table 12.

COST AND RISK OF EXISTING STOCK OF DEBT

30. As at end December 2021, the nominal total debt to GDP ratio is estimated at 62.1 percent, which is within the legislative limit of 70 per cent, provided for in Section 11 of the Public Debt Management Act. However, the present value of total public debt to GDP ratio is estimated at 50.9 per cent, against a threshold of 35 per cent prescribed under the Low-Income Country (LIC) DSA Framework. Table 13 shows the existing debt portfolio's selected cost and risk indicators.

31. The cost and risk indicators for external debt are being adversely affected by the continuous accumulation of external debt arrears. The weighted average interest rate of 0.2 per cent is relatively favourable, whereas the Average Time to Maturity of 3.9 years and Average Time to Refixing of 3.9 years, are relatively low reflecting arrears which are due and payable on demand, hence significant exposure to refinancing risk. This is also reflected by external debt maturing in 1 year as a percentage of total debt at 31.8 per cent and external debt refixing in 1 year as a percent of total debt of 46.6 percent. This points to arrears pausing a heightened refinancing risk for the debt portfolio.

- 32. The portfolio is vulnerable to foreign exchange rate risk as indicated by external debt being 78 per cent of total debt, as well as a short-term external debt to international reserves of 681.8 per cent. This implies that any movements in exchange rates will heavily impact the portfolio and will raise the cost of debt service.
- 33. Government has been financing the budget mainly from the domestic financial and capital markets as a result of the limited access to external financing due to accumulation of external debt arrears. The domestic debt maturing in one year as a percentage of total debt is 74.2 percent and the T-bills as a percentage of total domestic debt is 76.2 per cent, which reflects the dominance of short-term instruments and exposure of the debt portfolio to refinancing risk.




Figure 4: Redemption profile of external and domestic debt as at end December 2021

- 34. The redemption profile shown in Figure 4 indicates high refinancing risk, as shown by the spike in 2022. The higher projected debt service in 2022, reflects the external payment arrears accumulated since 2000, as well as short-term domestic debt.

35. Figure 5 shows the currency composition of the external debt portfolio, where USD- denominated debt constituted 46 per cent, EUR 31 per cent, CNY 8 per cent, JPY 7 per cent, GBP 6 per cent and other currencies constituting 2 per cent. In addition, the portfolio has fixed interest rate debt

of 86 per cent, with the balance of 14 per cent at variable interest rates, indicating a relatively low interest rate risk, taking into account the very low average fixed interest rate at below 1 per cent.



CONTINGENT LIABILITIES

Guarantees

- 36. Investments by public entities in infrastructure projects, contribute to the country's sustained and inclusive economic growth and developmental goals. To fund the infrastructure programmes and projects, these entities borrow resources, leveraging their balance sheets.
- 37. Upon application, Government may decide to assist public entities (including private sector companies ¹) access cost-effective funding by providing guarantees. All public entities intending to borrow and or benefit from a Government guarantee are required to secure authority and approval from the Minister of Finance and Economic Development. Before granting the guarantee, a credit risk assessment of the beneficiary public entity is conducted by the External and Domestic Debt Committee² (EDDC) Working Party, to assess the capacity to service the guaranteed debt obligations.
- 38. The credit risk assessment is conducted using financial indicators, non-financial indicators and project feasibility (where applicable), in line with the Framework for Evaluating, Monitoring and Managing Guaranteed and On-lent Loans.
- 39. In summary, the process for guarantee requests and approvals is as follows:
 - The Minister responsible for the entity submits a request to the Minister of Finance and Economic Development for the issuance of a guarantee.
 - The EDDC WP assess the request on the basis of the guidelines as set out in the Framework and submits the recommendation to the EDDC for review and recommendation to the Minister of Finance and Economic Development.
 - After considering the EDDC's recommendation, the Minister of Finance and Economic Development decides whether a guarantee will be granted or not.

¹ Private sector companies will only be considered in special cases such as during pandemic to support economic recovery

² The EDDC is assisted by a technical committee, the EDDC Working Party

- 40. The ZPDMO rigorously monitors these contingent liabilities and their potential impact on the fiscus to ensure that fiscal risks associated with these contingent liabilities are contained, thus maintaining debt sustainability.
- 41. In 2021, Government approved and issued guarantees to several public entities including to two private sector companies as shown in Tables 15 and 16. Credit risk assessment were conducted on all guarantee requests in line with the PDM Act and the Framework.
- 42. During the period January to December 2021, Treasury issued guarantees to domestic creditors amounting to ZWL\$35.66 billion and US\$ 64.75 million, of which more than 90 per cent was towards the agricultural sector.

Status of Outstanding Guarantees

- 44. As at end December 2021, outstanding guarantees amounted to US\$1.31 billion and ZWL\$70.88 billion as indicated on Table 17. The ZPDMO monitors these outstanding guarantees on a regular basis to ensure that all payments are on track and to mitigate fiscal risks.
- 45. Challenges are being faced with respect to guarantees issued for agricultural support, where recovery rates are very low, except for the 2020 winter wheat cropping season, with a recovery rate of 74 per cent. In this regard, beginning 2021 and going forward, the creation of a dedicated sinking fund to service the debt, is now a condition for issuance of a guarantee. Outstanding guarantees issued to AMA, IDBZ and AFC have dedicated sinking funds with ringfenced resources for repayments. The US\$3.5 million Sub-Sahara Tobacco guaranteed facility which expired on the 31st of December 2021, is now in arrears and negotiations for restructuring to extend the repayment period are underway.

Borrowing Power Certificates

- 46. In 2021, Government approved and issued borrowing power certificates to several public entities as shown in Table 18. All borrowing requests go through a credit risk assessment, similar to the one for guarantees, to ensure that borrowing power certificates are issued to credit worthy entities.
- 47. During the period under review, Treasury granted authority to borrow to six public entities, amounting to a total of US\$22.7 million and ZWL\$988.1 million for financing working capital and capital expenditure.

GLOSSARY

Arrears: The total of scheduled debt service payments that have fallen due but remain unpaid.

Assumed Debt: Legacy debt taken over by the Government of Zimbabwe through an Act of Parliament.

Bilateral Creditor: In DMFAS, it refers to official bilateral creditors which include governments and their agencies (including Central Bank), autonomous public bodies or official export credit agencies.

Bilateral Debt: Loans extended by a sovereign bilateral creditor.

Borrower (debtor): The organization or the entity defined as such in the loan contract which usually is responsible for servicing the debt.

Commercial Credit: In the context of the Paris Club, loans originally extended on terms that do not qualify as official development assistance (ODA) credits.

Commitment: An obligation to pay for a given amount under specified financial terms and conditions.

Concessional Loans: Loans that are extended on terms substantially more generous than market loans.

Concessionality Level: See grant element.

Contingent liability: Obligations that do not arise unless a particular, discrete event(s) occurs in the future. Contingent liabilities can be explicit or implicit. Explicit contingent liabilities are obligations based on contracts, laws, or clear policy commitments. Implicit contingent liabilities, on the other hand, are moral obligations and sometime arise from expectations that government would intervene in the event of a crisis or a disaster.

Creditor: The organization or entity that provides money or resources and to whom payment is owed under the terms of a loan agreement.

Creditor Country: The country in which the creditor resides.

Currency of Repayment: The unit of account in which a loan is to be repaid.

Currency of Reporting: The unit of account in which amounts are reported to the compiling agency and/or to an international agency compiling debt statistics.

Debt Cancellation: The amount of debt forgiven by a creditor.

Debt Distress: An unsustainable debt position, where a country is accumulating arrears.

Debt Overhang: Is a debt burden that is so large that a country cannot unlock new financing to finance future projects.

Debt Relief: Any form of debt reorganization that relieves the overall burden of debt.

Debt Rescheduling: Debt rescheduling refers to the formal deferment of debt service payments and the application of new and extended maturities to the deferred amount.

Debt Service: Refers to payments in respect of both principal and interest.

Debt-Service to Export Ratio: The ratio of debt service (interest and principal payments due) during a year, expressed as percentage of exports (typically of goods and services) for that year.

Debt Sustainability Analysis: A study of a country's medium- to long term debt situation.

Disbursed Loans: The amount that has been disbursed from a loan but has not yet been repaid or forgiven.

Disbursed and Outstanding Debt (DOD): The amount that has been disbursed from a loan commitment but has not yet been repaid or forgiven.

Domestic Debt: Gross domestic debt, at any given time, is the outstanding contractual, and not contingent, liabilities that residents of a country owe to other residents of the country that require payment(s) of interest and/or principal by the debtor at some point(s) in the future.

External Debt: Gross external debt, at any given time, is the outstanding amount of those actual current, and not contingent, liabilities that require payment(s) of interest and/or principal by the debtor at some point(s) in the future and that are owed to non-residents by residents of an economy.

Government Bonds: Negotiable securities issued by the government. They are long term obligations issued with maturity of more than 1 year.

Grace Period: The period between the commitment date of the loan and the date of the first principal repayment.

Grant Element: The measure of concessionality of a loan, calculated as the difference between the face value of the loan and the sum of the discounted future debt service payments to be made by the borrower expressed as percentage of the face value of the loan.

Guarantee of a loan: An undertaking by the government to pay part or all of the amount due on a debt instrument extended by a lender in the event of non-payment by the borrower.

Line of Credit: An agreement that creates a facility under which one unit can borrow credit from another up to a specified ceiling usually over a specified period of time.

Loan: An agreement in which a lender undertakes to make specified resources available to a borrower. The amount of funds disbursed is to be repaid (with or without interest and late fees) in accordance with the terms of a promissory note or repayment schedule.

Loan Agreement: The legal evidence and terms of a loan.

Loan Currency: The unit of account in which a loan was borrowed

Maturity Date: The date on which a debt obligation is extinguished.

Medium-Term Debt Management Strategy (MTDS): is a plan that the Government intends to implement over the medium term in order to achieve a desired composition of the Government debt portfolio, which captures the Government's preferences with regard to the cost-risk trade off.

Multi-Currency: Adoption of a basket of currencies as legal tender.

Multilateral Creditors: Multilateral institutions such as the IMF and the World Bank, African Development Bank, European Investment Bank as well as other multilateral development banks.

Non – Paris Club Creditors: Creditors not in the Paris Club (See Paris Club).

Official Development Assistance (ODA): Flows of official financing administered with the promotion of the economic development and welfare of developing countries as the main objective, and which are concessional in character with a grant element of at least 25 percent (using a fixed 10 percent rate of discount).

Paris Club: An informal group of creditor governments that has met regularly in Paris since 1956 to reschedule bilateral debts; the French treasury provides the secretariat.

Penalty Interest Charges: This is the additional interest that may be levied on obligations overdue beyond a specified time.

Primary Surplus/Deficit: The difference between Revenues and Expenditures (less interest payments)

Private Creditors: Creditors that are neither government nor public sector agencies. These include private bondholders, private banks, other private financial institutions, and manufacturers, exporters, and other suppliers of goods that have a financial claim.

Public Sector: The public sector includes the general government, monetary authorities, and those entities in the banking and other sectors that are public corporations.

Repayment Period: The period during which the debt obligation is to be repaid.

Service Charges: All charges that must be paid as a cost for the loan, such as: interest, commitment fees, management fees.

Short-term Debt: Debt that has maturity of one year or less.

Statutory Funds: Monies set aside for a specific purpose by an Act of Parliament

Supplier Credit: A loan extended by an exporter to finance the purchase of that exporter's goods or contractual services.

Treasury Bills: Negotiable securities issued by the Government. In general, these are short term obligations issued with maturity of one year or less. They are traded on a discount basis.

Undisbursed Balance: Funds committed by the creditor but not yet utilized by the borrower.
